Aadhaar seeding with PAN

This is with reference to our circular Nos. NSE/ISC/48165 dated May 03, 2021, NSE/ISC/49477 dated September 01, 2021, NSE/ISC/49791 dated Sep 30, 2021, NSE/ISC/51579 dated March 9, 2022, NSE/ISC/51755 dated March 24, 2022, NSE/ISC/51828 dated March 30, 2022, NSE/ISC/55472 dated February 02, 2023, NSE/ISC/56173 dated March 28, 2023, NSE/ISC/56914 dated June 01, 2023 and NSE/ISC/57051 dated June 13, 2023 with regards to Aadhaar seeding with PAN.

In this context, Government of India vide its press release dated March 28, 2023 (copy attached), had extended the timeline for linking of PAN with Aadhaar to **June 30, 2023**. The extract of the same is as given below:

“In order to provide some more time to the taxpayers, the date for linking PAN and Aadhaar has been extended to June 30, 2023, whereby persons can intimate their Aadhaar to the prescribed authority for Aadhaar-PAN linking without facing repercussions”.

With regards to PAN-Aadhaar linking, in the event upon receipt of a confirmation from the investor's that their PAN is linked with their Aadhaar and the Trading Members observes that same is not reflecting in the Exchange database, they can either place a single unfreeze request (new request option) or a bulk unfreeze request (via file upload) on UCI online portal. Such records shall be verified by the Exchange. Kindly note, the facility will be applicable only when the PAN status is valid. Kindly refer Annexure I for file format.

It may be noted that the clients whose PAN is linked with Aadhaar as per UCC database on or before June 30, 2023, will be permitted to trade on the Exchange platform w.e.f July 01, 2023.

Further, subsequent to the due date of June 30, 2023, if the PAN-Aadhaar linking status is not updated in the Exchange database, then such clients shall neither be permitted to trade w.e.f Monday, July 01, 2023, nor will they be able to square up their open positions, until they comply with the aforesaid requirement. Eventually, such open positions will naturally expire on the expiry date of the respective contract.

The Trading Members are hereby advised to specifically monitor the open positions of such clients whose PAN is not linked with their Aadhaar and take appropriate measures to ensure compliance with the above.

Trading Members are advised to take note and comply with the above guidelines.

Last date for linking of PAN-Aadhaar extended

In order to provide some more time to the taxpayers, the date for linking PAN and Aadhaar has been extended to 30th June, 2023, whereby persons can intimate their Aadhaar to the prescribed authority for Aadhaar-PAN linking without facing repercussions. Notification to this effect is being issued separately.

Under the provisions of the Income-tax Act, 1961 (the 'Act') every person who has been allotted a PAN as on 1st July, 2017 and is eligible to obtain Aadhaar Number, is required to intimate his Aadhaar to the prescribed authority on or before 31st March, 2023, on payment of a prescribed fee. Failure to do so shall attract certain repercussions under the Act w.e.f. 1st April, 2023. The date for intimating Aadhaar to the prescribed authority for the purpose of linking PAN and Aadhaar has now been extended to 30th June, 2023.

From 1st July, 2023, the PAN of taxpayers who have failed to intimate their Aadhaar, as required, shall become inoperative and the consequences during the period that PAN remains inoperative will be as follows:

- (i) no refund shall be made against such PANs;
- (ii) interest shall not be payable on such refund for the period during which PAN remains inoperative; and
- (iii) TDS and TCS shall be deducted /collected at higher rate, as provided in the Act.

The PAN can be made operative again in 30 days, upon intimation of Aadhaar to the prescribed authority after payment of fee of Rs.1,000.

Those persons who have been exempted from PAN-Aadhaar linking will not be liable to the consequences mentioned above. This category includes those residing in specified States, a non-resident as per the Act, an individual who is not a citizen of India or individuals of the age of eighty years or more at any time during the previous year.

It is stated that more than 51 crore PANs have already been linked with Aadhaar till date. PAN can be linked with Aadhaar by accessing the following link <https://eportal.incometax.gov.in/iec/foervices/#/pre-login/bl-link-aadhaar> .
