PETRONET LNG LIMITED has informed the Exchange that Board of Directors at its meeting held on November 09, 2022 has approved an Special Interim Dividend of Rs 7/- per equity share of face value of Rs. 10/- each. The record date for the purpose of payment of dividend is November 22, 2022.

#### Adjustments for Futures Contracts:

Base price of the Futures contracts on November 21, 2022 will be reference rate less aggregate amount of dividend i.e. Rs. 7 /-. The reference rate to be reckoned for this purpose shall be the daily mark to market settlement price of the relevant futures contract.

#### Adjustments for Options Contracts:

The full value of dividend i.e. Rs. 7 /- would be deducted from all the cum-dividend strike prices on the exdividend date. The details of the old and corresponding new options contracts that shall be available for trading from November 21, 2022 would be notified on November 18, 2022.
