This is In continuation to Exchange Notice no. 20181030-34 dated 30th October 2018, wherein it was informed regarding discontinuation of Physical Settlement mode of Trading and Activation of new Groups “Y” and “ZY” in view of SEBI. circular no. LIST/COMP/15/2018-19 dated July 5, 2018

Trading Members are now hereby informed that SEBI vide Circular NO. SEBI/LAD-NRO /GN/ 2018/49 dtd. 30.11.2018 has extended the timeline for complying with the process to 1st April, 2019. In view of the same, trading in Physical scrips will be enabled on the Exchange Platform under P & ZP Group . The following scrips which are in Y and ZY group will be shifted back to P & ZP Group respectively w.e.f. 19.12.2018. Further, trading members are requested to note that companies which have not signed agreement with either of the depositories will be again shifted back to Y & ZY group effective from March 01, 2019.

Settlement of trade obligations in “Physical Delivery” mode, shall be discontinued from March 01, 2019, to allow for bad delivery cycle to be completed before the deadline of April 01, 2019.
