The contract.gz file made available to trading members on the NSE Extranet (Path: /faoftp/faocommon) from March 08, 2019 end of day will reflect the new weekly options contracts. Further, members are advised to load the above file in the trading application before trading on March 11, 2019.

Members may additionally note that for testing purpose certain strikes of the weekly option contract on NIFTY IT with expiry date March 14, 2019 shall be made available in the mock session scheduled on March 09, 2018 as per Exchange circular No. 39704 dated December 19, 2018. Details of these strikes shall be communicated to members vide a separate circular which shall be issued one day prior to the March 2019 contingency mock.

Members may note that there is no change in the structure of any of the reports.

The settlement procedure and details shall be intimated separately by NSE Clearing Limited.

Contract Specifications

The contracts specifications of the weekly options contracts are as given below:

Instrument Name	OPTIDX	
Symbol	NIFTYIT	
Expiry date	Every Thursday of the week. In case the Thursday is a trading holiday, the previous trading day shall be the expiry/last trading day. All contracts shall expire at the normal market closing time on the expiry day or such other time as decided by Exchange.	
Contract cycle	7 weekly expiry contracts excluding the expiry week of monthly contract. New serial weekly options contract shall be introduced after expiry of the respective week's contract.	
Strikes Price Interval	6-1-6 strikes (In the money-At the money-Out of the money) with 100 point interval.	

Note: All other contract specifications shall be in line with the monthly expiring NIFTYIT option contracts.
