The brief particulars of the Scheme of Arrangement are as mentioned below:

- a) The Hon'ble National Company Law Tribunal, Ahmedabad Bench vide its order dated September 21,2022 has approved the scheme of Arrangement between Aarti Industries Limited and Aarti Pharmalabs Limited and their respective shareholders and creditors.
- b) Appointed Date: July 01, 2021



c) Effective Date: October 17, 2022

d) Date of Allotment: October 21, 2022

e) Pursuant to the Scheme of Arrangement between Aarti Industries Limited and Aarti Pharmalabs Limited and their respective shareholders and creditors, sanctioned by the Hon'ble National Company Law Tribunal, Ahmedabad Bench; whereby upon coming into effect of the scheme and in consideration of;

For the transfer and vesting of the Demerged Undertaking i.e "Pharma Business" of Aarti Industries Limited into Aarti Pharmalabs Limited shall issue and allot Equity Shares to the shareholders of Aarti Industries Limited in the following proportion:

"1 (One) Equity Share of Rs. 5/- each, Fully Paid-Up of Aarti Pharmalabs Limited shall be issued and allotted for every 4 (Four) Equity Share of Rs. 5/- each Fully Paid-Up held in Aarti Industries Limited."

Prior to the Scheme, the paid-up Equity Capital of Aarti Pharmalabs Limited was Rs.25,00,000/- consisting of 2,50,000 equity shares of face value of Rs. 10/- each and the same shall stand cancelled upon the scheme coming effect.

The issued, subscribed and paid-up equity capital of Aarti Pharmalabs Limited post arrangement is Rs. 453130040/- consisting of 9,06,26,008 equity shares of face Value of Rs. 5/- each fully paid.
