The brief particulars of the Composite Scheme of Arrangement are as mentioned below:

a) The National Company Law Tribunal (NCLT), Ahmedabad Bench vide its order dated February 16, 2018 has approved the Scheme of Arrangement among Adani Enterprises

Limited (AEL) and Adani Green Energy Limited (AGEL) and their respective shareholders and creditors.

b) Appointed Date: April 01, 2018

c) Effective date: April 01, 2018

d) Date of Allotment: April 08, 2018

e) The Scheme provides for the transfer of the Renewable Power Undertaking (including all the estate, assets, rights, claims, title, interest and authorities including accretions and appurtenances of the Renewable Power Undertaking) be demerged from Adani Enterprises Limited (ADANIENT) and be transferred to and vested in Adani Green Energy Limited (ADANIGREEN) as a going concern.

In consideration of the transfer and vesting of the Renewable Power Undertaking into ADANIGREEN pursuant to the provisions of this Scheme, ADANIGREEN shall, without any further act or deed, issue and allot to each shareholder of ADANIENT, whose name is recorded in the register of members and records of the depositories as members of ADANIENT, on the Record Date, 761 (Seven Hundred & Sixty One) equity shares of Rs. 10/- (Rupees Ten Only) each of ADANIGREEN credited as fully paid-up for every 1000 (One Thousand) equity shares of Re. 1/- (Rupee One Only) each held by such shareholder in AEL ("New Equity Shares").
