The brief particulars of the Scheme of Arrangement are as mentioned below:

a) The National Company Law Tribunal, Mumbai Bench, Court II vide its order dated October 28, 2024 has approved the Composite Scheme of Arrangement between Emkay Taps and Cutting Tools Limited ("Demerged Company") and Emkay Tools Limited ("Resulting Company") and their respective shareholders under sections 230 to 232 and other applicable provisions of the Companies Act, 2013.

The scheme of arrangement inter alia provides for:

Demerger of Manufacturing Business (Demerged Undertaking) of Emkay Taps and Cutting Tools Limited (EMKAYTOOLS) and vesting the same into Emkay Tools Limited





(ETL), an unlisted wholly owned subsidiary (WOS) of Emkay Taps and Cutting Tools Limited.

The New Equity Shares to be issued and allotted by the Resulting Company to the shareholders of the Demerged Company in the following proportion:

"01 (One) Fully Paid-Up Equity Share of the Face Value of Re. 1/- each of Emkay Tools Limited for every 01 (One) Fully Paid-Up Equity Share of the Face Value of Rs. 10/- each held by such members in Emkay Taps and Cutting Tools Limited."

Prior to the Scheme, the paid-up Equity Capital of Emkay Tools Limited was Rs. 1,00,000/- (Rupees One Lakh only) consisting of 1,00,000 equity shares of Face Value of Re. 1/- each and the same was cancelled pursuant to Scheme of Demerger.

The issued, subscribed and paid-up equity capital of Emkay Tools Limited, post Arrangement is Rs. 1,06,71,300/- (Rupees One Crore Six Lakhs Seventy-One Thousand and Three Hundred only) consisting of 10671300 equity shares of face Value of Re. 1/-each fully paid.
