# "1 (One) Fully Paid-up Equity Share of Re.1/- each of ITC Hotels Limited for every 10 (Ten) Fully Paid-Up Equity Share of Re. 1/- each held in ITC Limited"

Prior to the scheme, the paid-up Equity Capital of ITC Hotels Limited was Rs. 83,00,00,000/-consisting of 83,00,00,000 equity shares of Face value of Re. 1/- each.
