The brief particulars of the Scheme of Arrangement are as mentioned below:

a) The Hon'ble National Company Law Tribunal, Chandigarh Bench, Chandigarh, vide its order dated May 19, 2023, has approved the Scheme of Arrangement between NIIT Limited (Transferor Company) and NIIT Learning Systems Limited (Transferee Company) and their respective shareholders and their respective creditors.

For Transfer and vesting of the Corporate Learning Group (CLG) business undertaking of NIIT Limited to NIIT Learning Systems Limited. NIIT Learning Systems Limited has issued and allotted Equity Shares to the shareholders of NIIT Limited in the following proportion:

"1 (One) equity share of the Transferee Company of face value of Rs. 2 each fully paid up is issued for every 1 (One) equity share of Rs. 2 each fully paid up held in the Transferor Company"



Prior to the Scheme, existing paid up share capital of the Transferee Company comprising of 11,55,64,072 equity shares of Rs.10/- each and the securities premium amounting to Rs. 2,00,00,000/- stand reduced and cancelled upon the scheme coming effect.
