- c) Effective date: October 19, 2022
- d) Date of Allotment: September 05, 2022
- e) Pursuant to the Scheme of Arrangement between Piramal Enterprises Limited, Convergence Chemicals Private Limited, Hemmo Pharmaceuticals Private Limited, PHL Fininvest Private Limited and Piramal Pharma Limited and their respective shareholders and creditors, sanctioned by the Hon'ble National Company Law Tribunal, Mumbai Bench; whereby upon coming into effect of the scheme and in consideration of the transfer and vesting of the pharmaceutical business and the financial services business,
