Demerger of "Manufacturing Business" (Demerged Undertaking), an unlisted wholly owned subsidiary of Hercules Hoists Limited ("HHL") into Indef Manufacturing Limited ("IML"), whereby upon coming into effect of the scheme and in consideration of;

"1 (One) Fully Paid-up Equity Share of Re. 1/- each of Indef Manufacturing Limited for every 1 (One) Fully Paid-Up Equity Share of Re.1/- each held in Hercules Hoists Limited"
