Modification in Aluminium, Aluminium Mini, Zinc, Zinc Mini, Nickel and Copper future contracts

In terms of the provisions of the Rules, Bye-Laws and Regulations of the Multi Commodity Exchange Clearing Corporation Limited (MCXCCL), the Clearing Members and their constituents are notified as under:

Accordingly, Members and their constituents are requested to take note that the existing stock of Aluminium, Aluminium Mini, Zinc and Zinc Mini stored at MCXCCL accredited warehouses located at National Capital Region (NCR) & Chennai delivery centers shall be eligible for delivery up to October 2025 expiry contracts.

Furthermore, the existing stock of Nickel and Copper stored at MCXCCL accredited warehouses located at National Capital Region (NCR), Chennai & Kolkata delivery centers shall be eligible for delivery up to August 2025 & November 2025 expiry contracts respectively.

Thereafter the beneficiary holders of stock are required to withdraw goods from MCXCCL accredited warehouses located at above-mentioned delivery centers.
