Subject : Modification in contract launch calendar – Rapeseed Mustard seed

(RMSEED) futures contract- Availability of February 2020 expiry contract

Members are requested to note that the Exchange, as per its Bye-laws, Rules and Regulations and with the approval of Securities and Exchange Board of India (SEBI), additional future contract of Rapeseed Mustard seed (Symbol: RMSEED) expiring in the month of February 2020 will be available for trading with effect from **December 02, 2019** with existing contract specifications. Contracts for further expiries will be launched as per the enclosed contract launch calendar.

The running futures contracts and contracts to be launched further shall be additionally governed by the Product Note as is notified on the Exchange Website under the Tab – "Products". Members and Participants are requested to kindly go through the same and get acquainted with the product launched and its trading and related process put in place by the Exchange.

Currently, Rapeseed -Mustard seed futures contracts expiring in the months of December 2019, January 2020, April 2020 and May 2020 are available for trading and would continue to be traded as per existing contract specifications.

Modified Contract Launch Calendar for contracts expiring in Year 2020 is given in **Annexure** I.

Premium/discount for delivery location difference for contract expiring in the month of February 2020 is given in **Annexure II.** 

The contracts and the transactions therein will be subject to Rules, Bye Laws and Regulations of the Exchange and circulars issued by the Exchange as well as directives, if any, issued from time to time by SEBI. It is clarified that it is the sole obligation and responsibility of the Members and market participants to ensure that apart from the approved quality standards stipulated by the Exchange, the commodity deposited / traded / delivered through the approved warehouses of NCCL neither on their own or on behalf of them by any third party acting on behalf of the Market Participants/Constituents is in due compliance with the applicable regulations laid down by authorities like Food Safety and Standards Authority of India, AGMARK, BIS, Warehousing Development and Regulatory Authority (WDRA) Orders under Packaging and Labelling etc., as also other State/Central laws and authorities issuing such regulations in this behalf from time to time, including but not limited to compliance of provisions and rates relating to GST, APMC Tax, Mandi Tax, LBT, stamp duty, etc. as applicable from time to time on the underlying commodity of any contract offered for deposit / trading / delivery and the Exchange shall not be responsible or liable on account of any noncompliance thereof.
