Peak Client Margin Reporting Advisory

In terms of provisions of the Rules, Bye-Laws and Regulations of Multi Commodity Exchange Clearing Corporation Limited (MCXCCL), with reference to SEBI circular SEBI/HO/MRD2/DCAP/CIR/P/2020/127 dated July 20, 2020 and in continuation to circular no. MCXCCL/C&S/286/2020 dated November 19, 2020;

MCXCCL has implemented peak client margin reporting requirement from November 02, 2020. Currently, 75% of peak client margin requirement is considered for client margin collection reporting.

In terms of the phased implementation of peak margin reporting requirement, 100% of peak margin requirement shall be considered for client margin collection reporting with effect from **trade date September 01, 2021**.

Other provisions of the above-mentioned circular shall continue to prevail.

Members and their clients / constituents are requested to take note of the same.
