#### The brief details about the Resolution Plan approved by NCLT is as follows:

- 1. The Resolution approved by Hon'ble National Company Law Tribunal vide order dated August 09, 2023 read with Interlocutory Application filed before the Hon'ble NCLT, Ahmedabad on March 11, 2024 and the order passed on June 04, 2024.
- 2. As per the Resolution Plan approved by Hon'ble National Company Law Tribunal the issued, subscribed and paid-up share capital of the Company shall stand reduced from Rs. 17,99,15,610/divided into 17991561 Equity Shares of the face value of Rs.10/- each to Rs. 54,50,000/- divided into 5,45,000 Equity Shares of the Face Value of Rs.10/- each.
- 3. Further, New 94,55,000 Equity shares of Rs 10/- each are issued on preferential basis by the Company.
- 4. The Company had fixed June 26, 2024 as record date for Reduction of Equity Share Capital of Innovative Tyres & Tubes Limited pursuant to the Resolution Plan approved by the Hon'ble National Company Law Tribunal vide order dated dated June 04, 2024
