The brief details about the Resolution Plan approved by NCLT is as follows:

- 1. The Resolution Plan was approved vide Order dated October 23, 2024, by the Hon'ble National Company Law Tribunal ("NCLT"), Hyderabad Bench, under the provisions of the Insolvency and Bankruptcy Code, 2016, ("IBC").
- 2. As per the Resolution Plan approved by Hon'ble NCLT:
 - a. After the capital reduction, public shareholders (including both the public and erstwhile promoters) will hold 10% of the Company's total issued, subscribed, and paid-up equity share capital. The remaining 90% of the shares will be allotted to the Successful Resolution Applicant (SRA) or its nominees.
 - b. Hence, public shareholding of 5,65,44,552 Equity shares of Rs. 10/- each is reduced to 5,65,44,552 equity shares of Re. 1/- each.
- 3. The Company had fixed December 06, 2024 as record date for giving effect to the resolution plan.
