### The brief details about the Resolution Plan approved by NCLT is as follows:

- 1. The Resolution Plan under the Provisions of the Insolvency and Bankruptcy Code, 2016 of the Company was approved by Hon'ble National Company Law Tribunal, Chennai Bench, vide order dated October 06, 2023.
- 2. As per the approved Resolution Plan, the Equity Shares held by existing Public Shareholders are restructured, reduced, reorganized, consolidated and extinguished (as required) such that the Equity Shares held by the existing Public Shareholders post such Capital reduction and Consolidation is 6,31,579 Equity shares of Rs.10/- each constituting 1% (One Percent) of the Issued and Paid Up Equity Share Capital of the Company, the issued, subscribed and paid-up share capital of the Company shall stand reduced from Rs. 42,40,52,240/- divided into 4,24,05,224 Equity Shares of the face value of Rs.10/- each to Rs. 63,15,790/- divided into 6,31,579 Equity Shares of the Face Value of Rs.10/- each.
- 3. Further, new 6,25,26,316 Equity shares of Rs 10/- each are issued on preferential basis by the Company.
- 4. The Company had fixed October 20, 2023 as record date for Reduction of Equity Share Capital of Viceroy Hotels Limited pursuant to the Resolution Plan approved by the Hon'ble National Company Law Tribunal, Chennai Bench, vide order dated dated October 06, 2023.
