Subject : Review of Volatility Scan Range (VSR) for Option contracts in Commodity

Derivatives Segment

This is with reference to SEBI circular No. SEBI/HO/CDMRD/DRMP/CIR/P/2021/08 dated January 11, 2021 and NCCL circular no NCCL/RISK-040/2022 dated October 14, 2022 on Review of Volatility Scan Range (VSR) for Option contracts in Commodity Derivatives Segment.

In this context, Clearing Members are hereby informed, that the Volatility Scan Range (VSR) for Options contracts in commodity derivatives segment has been reviewed for the month of December 2022. The VSR has been revised for Turmeric from 7% to 8%. There is no change in VSR for the remaining commodities. The VSR shall be as follows:

Coriander	DHANIYA	10%
Guar Gum Refined Splits	GUARGUM5	8%
Guar Seed	GUARSEED10	7%
Jeera	JEERAUNJHA	8%
Maize - Feed/Industrial Grade	MAIZE	11%
Turmeric	TMCFGRNZM	8%

The circular shall be effective from the beginning of trading day December 01, 2022.
