Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (“SOP Circular”), Members of the Exchange are hereby informed that Setubandhan Infrastructure Limited has been identified as non-compliant with Regulation 33 (i.e., Submission of Financial Results) of SEBI (LODR) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters’ i.e. December 31, 2022 and March 31, 2023. Details are as under: -

Further, it has been observed that S.S. Infrastructure Development Consultants Limited has been identified as non-compliant with Regulation 33 (i.e., Non submission of Financial Result) of the Listing Regulations for two consecutive quarters’ i.e., September 30, 2022 and March 31, 2023 (SME Company hence compliance status of September 30, 2022 and March 31, 2023 quarters is taken into account). Details are as under: -

Therefore, trading in securities of the above-mentioned companies shall be transferred to ‘Z’ (“BZ/SZ Series”) Category with effect from August 11, 2023, if the above-mentioned companies do not comply with Regulation 33 of the SEBI (LODR) Regulations, 2015 as per the provisions of SOP Circular on or before August 08, 2023.

The below mentioned Companies have also been identified as non-compliant companies under Regulation 33 i.e., (Submission of Financial Results) of SEBI (LODR) Regulations, 2015 for two consecutive quarters’ i.e. December 31, 2022 and March 31, 2023. Hence the trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (“BZ” Series) with effect from August 11, 2023, for the said non-compliance. However, securities of these companies are already trading in ‘Z’ Category pursuant to various Exchange Circulars, details of which are as under: -
