Clearing and Settlement Holiday on April 1, 2019 and Revised Settlement Schedule for BRASSPHY and ALUMINIUM March 2019 Contracts

In terms of the provisions of the Rules, Bye-Laws and Regulations of the Multi Commodity Exchange Clearing Corporation Limited (MCXCCL), Members of the MCXCCL/MCX are notified as under:

On account of Yearly Closure of Banks on April 01, 2019, there will be no fund settlement related activities on Monday April 01, 2019. Pay-In and Pay-out of Friday March 29, 2019 and Monday April 01, 2019 shall be executed on Tuesday April 02, 2019
