#### Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020, Members of the Exchange are hereby informed that the below mentioned Companies have been identified as Non-compliant with Regulation 17(1) (i.e. Composition of the Board) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations') for two consecutive quarters' i.e. June 30, 2021 and September 30, 2021. Therefore, the trading in securities of these companies is eligible to be transferred to 'Z' Category ('Z' Series) with effect from January 03, 2022, for the said non-compliance.
