Sub: Withholding payout for certain trades dated September 12, 2025

Vide directions received from the Enforcement Authority on September 15, 2025 the Exchange has been advised to stop all fraudulent transactions/activities executed in the trading account of the complainant on September 12, 2025, till further instructions.

Accordingly, the securities and funds payout w.r.t certain client(s) who were counterparties for the said trades in certain stocks have been withheld. The matter is under investigation with the Enforcement Authority. The Exchange has issued relevant communication to the respective trading members along with stocks details.

Any change/modification to the said withholding pursuant to the further directions from the Enforcement Authority shall be communicated to the trading members.
