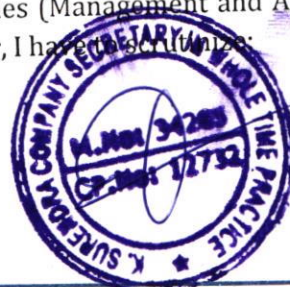

I, K Surendra, Company Secretary in Practice, have been appointed as the Scrutinizer by the Board of Directors of Steel City Securities Limited (the Company) having its Registered Office at "Steel City Heights", # 50-81-18, Main Road, Seethammapeta, Visakhapatnam -530016, Andhra Pradesh, India, for the purpose of scrutinizing the remote e-Voting and Voting through ballot paper at the Annual General Meeting in terms of Sections 108 and 109 of the Companies Act, 2013 (the Act) read with Rule 20 and Rule 21 of the Companies (Management and Administration) Rules, 2014 (the Rules) (as amended from time to time), Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Secretarial Standard - 2 on General Meetings as issued by the Institute of the Company Secretaries of India, on the Resolutions contained in the Notice of 30th Annual General Meeting (AGM) of the Members of the Company held on Saturday, the 28th day of September, 2024 at 11.45 A.M. at its Registered Office.

1. The said appointment as Scrutinizer is under the provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As the Scrutinizer, I have the honor to

- i. Process of remote e-voting, before the AGM, using an electronic voting system on the dates referred to in the Notice calling the AGM ("remote e-voting"); and
- ii. Process of voting at the AGM through ballot paper.

Management's Responsibility

2. The management of the Company is responsible to ensure compliance with the requirements of:
 - i. the Act and the Rules made thereunder;
 - ii. the MCA Circulars; and
 - iii. the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the Resolutions contained in the Notice calling the AGM.

The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

Scrutinizer's Responsibility

3. My responsibility as Scrutinizer for Voting process (i.e., remote e-voting and voting through Ballot Paper at AGM) is restricted to making a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the Resolutions contained in the Notice, based on the reports generated from the e-voting system provided by Bigshare Services Private Limited, the Agency authorized under the Rules and engaged by the Company to provide e-voting facility and attendant papers / documents furnished to me electronically by the Company and/ or Bigshare Services Private Limited for my verification.

Cut-off date

4. The Equity Shareholders of the Company as on the "cut-off" date, as set out in the Notice, i.e., 21st day of September, 2024 were entitled to vote on the resolutions (item nos. 01 to 04 as set out in the Notice calling the AGM) and their voting rights were in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date.

5. Remote e-voting process/voting process through ballot paper at the AGM:


- i. The remote e-voting period remained open from Wednesday, the 25th day of September, 2024 (9:00 A.M. IST) to Friday, the 27th day of September, 2024 (5:00 P.M. IST) and members were required to cast their votes electronically conveying their assent or dissent in respect of the Resolutions on the remote e-voting platform provided by Bigshare Services Private Limited.



- ii. The facility for voting through ballot paper was provided at the 30th AGM on Saturday, 28th September, 2024 for those members who attended the meeting but not voted through remote e-voting facility.
- iii. The votes cast were unblocked on Saturday, 28th September, 2024 after the conclusion of the AGM and was witnessed by two witnesses, Mr. B. Krishna Rao and Mr. L. Appala Naidu, who are not in the employment of the Company and/ or Bigshare Services Private Limited. They have signed below in confirmation of the same.
